

Please refer to this office letters of even number dated 19th October, 2012, 8th September, 2014, 10th March, 2015, 23rd June, 2016 and 11th July, 2016 regarding creation of 2 seats under Supernumerary Quota for students from Jammu & Kashmir.

The Ministry of Human Resource Development has decided that for smooth implementation of the scheme, for the current academic year only those students would be considered for award of scholarship under the scheme who have been provided admission through centralized counselling to pursue either general/engineering/nursing degree courses in universities/colleges u/s 2(f) and 12B of the UGC Act or recognised by AICTE or taken admission on their own to Central Universities or Engineering/Medical Colleges based on Government conducted National Level Examination.

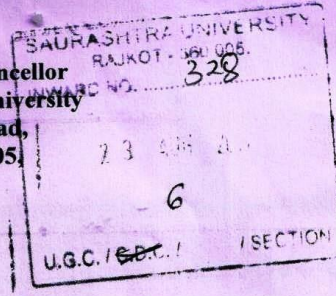
