Sir,

I am directed to state that several instances of making fake Scheduled Caste (SC)/ Scheduled Tribe (ST)/ Other Backward Classes (OBC) certificates to get admission in the educational institutions in the country are being reported from time to time. This issue has also been raised in Parliament Questions in the recent past. Copies of replies give in Lok Sabha Unstarred Question No.517 for 26.11.2014 and Lok Sabha Unstarred Question No.2474 for 1.8.2016 are enclosed for ready reference.

2. In this connection, the UGC is requested to furnish information on the following:-

- a) The standard procedure adopted by the Universities/Colleges about complaints received regarding making of fake SC/ST/OBC certificates to get admission in the educational institutions in the country.
- b) How many such cases during the past three to four years have come to the notice of Universities/Colleges/Schools, etc, and in how many cases, the certificates have been found to be fictitious?
- c) what action has been taken by the Universities/Colleges/Schools, etc. against the students adopting such fraudulent method to get admission in educational institutions.
- d) whether the UGC has a database on the number of complaints received regarding the use of fake SC/ST/OBC certificates to get admission in the educational institutions in the country along with the action taken thereon?
- e) If so, the data State-wise, University-wise, college-wise information from the academic year 2010-2011 onwards may please be furnished to the SC/ST Division, MHRD, at the earliest.
- f) If not the UGC is requested to put in place a mechanism to collect such data with details of the cases, College-wise, University-wise and State-wise and send the information to the Ministry at the earliest.
