Sir,

I am directed to say that the Executive Committee of Board of Governors of the Council in its meeting held on 29.10.2018 considered the draft amendments in Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations 2013 and after threadbare discussions, it recommended the draft amendments with some modifications (draft amendments annexed as Annexure-A).

The Board of Governors of Central Council in its meeting held on 30.11.2018 ratified the said recommendation of the Executive Committee meeting held on 29.10.2018.

It is therefore, requested to all State/U.T. Govts. to send their comments on said proposed amendments in Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations 2013 to this Council **within three months** from the date of its issue as per provisions of Section 20(2) of Homoeopathy Central Council Act, 1973.

**ANNEXURE - A**

**Requirements of Minimum Standard under regulation 3 for grant of permission-**

(1) (a) The Homoeopathic colleges established under section 12A and existing Homoeopathic Colleges under section 12C of the Act and their attached hospitals shall fulfill the requirements of minimum standard for infrastructure and teaching and training facilities referred to in the regulations 4 to 13 up to the 31st December of every year for consideration of grant of permissions for undertaking admissions in the coming academic session;

(b) the Central Council shall inspect these colleges suo moto three months before the expiry of permission;

(c) after submission of report or inspections by the inspection team to the Central Council, the Central Council shall submit its recommendation to the Central Government within a period of one month from the date of submission of report by the inspection team;

(d) The homoeopathic college shall certify that teaching faculty present in the college is not working at any other place.

(e) the position prevailing on the date of inspection to assess the fulfillment of requirements as specified in these regulations except sub regulation (2) of regulation 7 shall be taken into consideration for grant of conditional permission for a period of one year or permission for a period of five years to the colleges.

**Requirements of Minimum Standard under regulation 3 for grant of permission for a period of five years-**

2(a) After fulfillment of the requirement as per these regulations by the college, the permission shall be granted to undertake admissions for a period of five years. The college shall be randomly inspected within the said period on receipt of any complaint; or if from online Bio-metric attendance it is found that teaching, non-teaching staff, hospital staff are not present regularly, or hospital is not properly functional, or otherwise as required by the Central Government or by the Central Council;

(b) any deficiencies arising within the said period shall be fulfilled by the college within one hundred and fifty days under intimation to the Central Council, otherwise the permission for a period of five years deemed to be withdrawn;

(c) colleges which were permitted for a period not exceeding five years shall maintain the requirements as specified under the regulations 4 to 13 otherwise the permission for a period of five years deemed to be withdrawn.



**Requirements of Minimum Standard under regulation 3 for grant of conditional permission of one year-**

3(a) The conditional permission of one year for particular academic session shall be granted only to those colleges which are fulfilling following requirements on the basis of the inspection by the Central Council between the 31st December to the 31st March or any other date as may be decided by the Central Government for the succeeding academic session:

- (i) the requirement of teachers as specified in the Schedule-IV for UG Course and schedule V for PG Courses;
- (ii) the requirement of teaching hospital as specified under sub-regulation (2) of regulation 7;
- (iii) availability of minimum seventy-five percent of required equipment in each department as specified in the Schedule-VII;
- (iv) availability of hospital staff as specified in the Schedule-II,
- (v) availability of technical and other staff as specified in the Schedule-VI;
- (vi) availability of college council as specified in sub-regulation (1) of regulation 10;
- (vii) availability of college website as specified in sub-regulation (4) of regulation 10;
- (viii) availability of biometric attendance as specified in sub-regulation (5) of regulation 10; and
- (ix) availability of minimum constructed area of college and hospital as specified in regulation 5.

(b) the colleges, which are granted conditional permission or which are denied permission for the academic session starting with the academic year 2019-20 and onwards shall be required to fulfill the requirements as specified above in clause (a) to obtain the conditional permission of one year for particular academic session or for a period of five years as specified in the regulations 4 to 13.

सं. 12-15/2012-के०हो०प०(पार्ट)।—केन्द्रीय होम्योपैथी परिषद्, होम्योपैथी केन्द्रीय परिषद् अधिनियम, 1973 (1973 का 59वाँ) की धारा 33 के खण्ड (अ) के द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, केन्द्रीय सरकार की पूर्वानुमति से एतद् द्वारा होम्योपैथी केन्द्रीय परिषद् (होम्योपैथी महाविद्यालय तथा संलग्न अस्पतालों के लिए न्यूनतम मानक स्तर) विनियम, 2013 में संशोधन हेतु निम्न विनियम बनाती है, अर्थात् :-

1. लघु शीर्षक एवं प्रारंभ.—(1) इन विनियमों का नाम होम्योपैथी केन्द्रीय परिषद् (होम्योपैथी महाविद्यालय तथा संलग्न अस्पतालों के लिए न्यूनतम मानक स्तर) संशोधन विनियम, 2018 होगा।  
(2) ये भारत के आधिकारिक राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।
2. (i) होम्योपैथी केन्द्रीय परिषद् (होम्योपैथी महाविद्यालय तथा संलग्न अस्पतालों के लिए न्यूनतम मानक स्तर) विनियम, 2013 में—विनियम 9 के पश्चात्, निम्न विनियम को जोड़ा जाएगा अर्थात्:-  
“9अ उपस्थिति:—शिक्षण कर्मचारी वृंद, गैर शिक्षण कर्मचारी वृंद, अस्पताल कर्मचारी वृंद तथा स्नातकोत्तर विद्यार्थियों की उपस्थिति, आधार आधारित भौगोलिक स्थान सक्षम बायोमैट्रिक उपस्थिति प्रणाली द्वारा होगी, जिसे केन्द्रीय सरकार तथा केन्द्रीय परिषद् को सत्यापन हेतु सुलभ कराया जाएगा।
- (ii) विनियम 10 में, उप विनियम (5) को हटाया जाएगा।

No. 12-15/2012-CCH(Pt.).—In exercise of the powers conferred by clause (i) of section 33 of the Homoeopathy Central Council Act, 1973 (59 of 1973), the Central Council of Homoeopathy, with the previous sanction of the Central Government, hereby makes the following amendments in the Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations 2013, namely:-

1. **Short title and commencement.**—(1) These regulations may be called the Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) amendment Regulations 2018.  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. (i) In the Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations, 2013, after regulation 9, the following regulation shall be inserted namely:-

“9A Attendance:- The attendance shall be through Aadhar Based Go location enabled Biometric Attendance system for teaching staff, non-teaching staff, hospital staff and post graduate students, which shall be made accessible to the Central Government and Central Council for verification”.

- (ii) in regulation 10, the sub-regulation (5), shall be omitted.
